

ACT! OFFSHORE Live training with actors

The live training gives the leaders an actual, physical experience with their theoretical knowledge in a highly realistic situation – but with a unique opportunity to "pause", "rewind", reflect and learn during a challenging situation.

This method makes leaders able to implement the theory in their leadership before returning to work. And thereby giving leaders the opportunity to try out different kinds of leadership approaches in a safe forum, avoiding real-life consequences.

EFFECT – change in leadership behavior leading to reduced number of near accidents.

HOW - Learning by doing

The professional corporate actors play the roles as realistic employees and are educated in instant customizing of challenges to ensure the highest level of learning.

We can base the training on different leadership challenges, e.g.:

- Conflict handling
- Handling pressure
- Situational leadership
- Challenged communication and change management

WHAT - Overall learning skills


The leaders will be learning about their own reactions and dealing with them in a pressure environment.

They will be training their communication skills and the appropriately matching behavior.

- Values, allergies and dilemma decisions.
- Take time, make agreement, and be observant.
- Time, reptile reactions and proactive prioritization.
- Communication and change management.
- Agreements, motivation and delegation.
- Open questions and the skill/will prism.
- Observations, feedback & body language.
- Intervention and conflict management.

Client provide the administrative program (coordination, accommodation etc., hiring the simulator, transport etc.).


